- Before starting your application, please contact the International Office of your home university and apply for pre-selection
- Once you have been declared eligible by your home university you must fill in an online application on www.hec.edu/MiM:
 1. Create your account
 2. Select:
 - “GE/MiM - Master in Management Grande Ecole” program
 - “Only HEC International Partners pre-selected candidates” option
 - “Summer 2016” session
 3. Complete the 5 parts of the application and submit.

- Transcripts
- Certificate of enrolment
- CV (Résumé)
- Proof of identity
- 2 online recommendations from Professors. A third may be added by a professional.
- Passport-style photo.

ADMISSION CALENDAR

- **Invitation to interview:**
2 to 3 weeks after application deadlines
- **Final admission results:**
6 to 8 weeks after application deadlines.
